ESSENTIAL JOB FUNCTIONS:

- 1. Provides child-care.
- 2. Maintain accurate attendance records.
- 3. Develop and facilitate daily curriculum of planned activities.
- 4. Facilitate children’s circle time.
- 5. Assist with meal/snack provision to children in care.
- 6. Other duties as assigned.

JOB DUTIES:

- 1. Provide childcare.
 - A. Supervise and insure safety of children in care
 - B. Organize room and materials before children arrive, and straighten room and materials after children leave
 - C. Make sure that floors and table surfaces are sanitized at the end of each shift.
 - D. Make sure that toys are clean and in safe working order
 - E. Inform Administrator of any needed repair.
- 2. Maintain accurate attendance records
 - A. Assure that there is completed registration file for every child in care
 - B. Monitors sign-in of parents as they deliver their children to child-care.
 - C. Submits attendance sheets to child care Administrator weekly
- 3. Develop and facilitate daily curriculum of planned activities
 - A. Provides activities for children of a varied age range which afford the following needs:
 - 1. The opportunity to participate in fine and gross motor play
 - 2. The opportunity for creative expression

- 3. In-door large muscle activities on inclement days
 - 4. Both social interaction and individual play
 - 5. Learning of social skills, such as using words rather than fists to problem solve
 - B. Maintains order through appropriate discipline methods
 - C. Consults with Administrator about any problems encountered with children,
- 4. Facilitate children's circle time
 - A. Foster problem solving and conflict resolution abilities among children
 - B. Foster communication skills among children
 - 5. Assist with meal/snack provision to children in care
 - A. Prepare meal/snack according to menu
 - B. Develop and reinforce positive table manners
 - 6. Other duties as assigned

KNOWLEDGE, SKILLS, AND ABILITIES:

Ability to work effectively with children and parents, demonstrate patience, creativity and versatility in working with people of varying abilities. Knowledge of child behavior, non-punitive discipline techniques, and respectful communication methods. Ability to remain objective and perform duties under pressure. Ability to deal with unruly children. Ability to communicate with parents concerning their children's behavior, needs, and experience. Sensitivity to diversity of culture and lifestyle. The ability to plan and lead enjoyable activities for children within a wide age range. Must be well organized and able to prioritize workloads and set realistic goals for self and children. Ability to work collaboratively. A natural liking for children.

QUALIFICATIONS:

Childcare experience preferred. Must pass a child care provider background check, have CPR and First Aid certification and participate in a minimum of 12 hours of child care related training annually.
